14/NP78 Draft Skeleton Neighbourhood Plan

The following information was requested for Chapter 5 of the draft plan:

- Sites with planning permission Para 5.4 and 5.5 : clerk to make enquiries of Bradford MDC as to current status.
- Heritage sites: clerk to obtain list from Bradford MDC. Silsden history group to be approached (R Whitacker)
- Schools: no sites currently allocated in the NP area
- Employment zones: Rebecca and Michael to consider employment zone at Keighley Rd Silsden and Silsden local centre
- Bus Link: Clerk to make enquires at Bradford Highways.
- Elliot St/Keighley Road junction: clerk to ascertain current status

- Sykes Lane in Silsden needs protecting as a heritage/green route. Is it protected at present? What are plans for it? (to left as go in to Silsden)
- 5.9 Urban Green Spaces: all listed in draft plan to be carried forward, to include green spaces between terraced house in Silsden and all space owned by local Councils. Clerk to list additional areas owned by Steeton-with-Eastburn Parish Council, and to ask Silsden clerk to provide details of any in Silsden
- 5.10 Sites of ecological or nature conservation importance: to add Currer wood,
 Hawkcliffe Wood, Eastburn Moor, Pot Lane as it goes through Airedale site, Silsden
 moor areas. Cllrs to review conservation assessment for Silsden (R Whitaker) and
 Steeton with EAstburn (R. Lambert). To find out the status of a triangle of land off
 High Street on right near Seedhill Terrace.

Other issues to be included/considered

- Bridge over bypass/subway: Bradford have put some money aside for this (probably not enough) put they do not own enough land to create sufficiently long ramps. Request for a safe crossing route to be included in plan.
- Improvements to Station access need to be included in the NP
- Cycle and footpath links
- Silsden Eastern bypass: no more houses to be built to West of Silsden without the bypass being constructed

Housing: 5.13 approx 250 houses have already been given permission in Steeton and Eastburn, number to be found will thus be 700-250 i.e.500. Number with permission in Silsden to be ascertained.

School: only potential site is in Silsden, behind the Methodist church. Current plan is to put infant and junior schools together on one site but to keep the same capacity.

6.7: housing design policy: Resolved to include a housing design policy, which will include the following: a limit to 2 storey buildings, (except for conversions of existing taller buildings); new build to reflect existing housing stock, similar in design to adjacent dwellings; density criteria; all hard standing to be permeable.

The meeting adjorned after considering at section 6.8 of the draft plan.

Airedale hospital: Cllr Mullen and the clerk met the director of strategy and the estates manager on 26th February. They are concerned about egress from their site, difficulties are caused by queuing traffic. They are working with local bus operators to provide a bus service to and from Skipton and Keighley. Cllr Mullen requested that this service stop at the station. They will be informed of the call for sites.
